READING OF THE OPEN PUBLIC MEETINGS ACT STATEMENT: Notice of this meeting complies with the Open Public Meetings Act. Public Notice was given to the Ocean County Gazette and was published in the Ocean Star on January 8, 2010. Notice was also posted on our Municipal Website and the Municipal bulletin board.

MOMENT OF SILENCE: Council President Zalom read out loud a prayer for our soldiers. She then asked for a moment of silence for Mary Sandy, a resident of West Point Island who recently passed away and for Mary Buonocore, who was the mother of a summer resident. She also asked for a moment of silence for Trooper Marc Castellano, who was killed recently while on duty.

PLEDGE OF ALLEGIANCE: Councilman Borowski led us in the Salute to the Flag.

MAYOR'S WELCOMING STATEMENT: Council President Zalom thanked everyone for coming to the meeting tonight.

COMMENTS FROM PUBLIC (Items not listed on agenda / not staying for remainder of meeting)

Council President Zalom opened the floor to anyone who wished to comment on any items that were not on the agenda and did not wish to stay for the remainder of the meeting.

Ken Phillips, 105 Elizabeth Avenue stated that he was here about five years ago with this same problem. The flooding by his house is so bad that it comes into his home. His elderly mother lives there and it has become very troublesome for her. There was an investigation as to why there was so much water and it was determined that the root of his neighbor's tree was causing the problem. They did the best they could but until the tree was removed they could not go any further. In the meantime, his neighbor gave permission to cut down the tree but the flooding has continued. He asked if there anything else that can be done.

Mr. Parlow stated that the tree was cut down but some of the root is still wrapped inside a section of the pipe. Mr. Parlow stated that he has sent a letter to the State explaining to them that the tree was removed and that there is a section of the pipe that needs to be replaced. Mr. Parlow stated that he will send out another letter to the State.

Ruth Antolino, 11 Dover Avenue stated that she sees dogs on our beach all the time. She asked if there are any fines that can be issued to stop this problem.

Councilwoman Filippone stated that the only way to enforce it is when you see a dog on the beach call the police department and let them know. Now is the season so the police will be patrolling more but in the off season the police are not up there as much so you need to call and let them know. The signs should be visible from the walkways.

Clem Boyers, 20 Kerr Avenue stated that the rule signs are up and the dog signs are in the walkways and are visible.

COMMENTS FROM THE PUBLIC:

Clem Boyers, 20 Kerr Avenue stated that the parking situation was discussed when the employees of the Crab's Claw were taking up all the spaces on President Avenue. He stated that it seems to him that it is what it is.

Mr. Parlow stated that he will still talk to the Captain and maybe something could be worked out.

Ken Phillips, 105 Elizabeth Avenue questioned what Lavallette is doing about the new law that was passed about stopping for pedestrians. He asked if the police going to put out those pedestrian signs.

Council President Zalom stated that because we have a two lane highway, it is very dangerous for pedestrians because one lane will stop but the other lane will not. The cones are not worth putting out because if a car hits it that could cause an accident or hit someone.

Councilwoman Filippone stated that she has spoken to the Chief about putting the cones away from the highway closer to the angle parking so that once a person gets to that cone the cars should see

them and know to stop. In the meantime, he is utilizing our special officers to enforce the pedestrian crossing and the bicycle problems.

COMMENTS OF THE MAYOR AND COUNCIL MEMBERS:

Councilman Borowski thanked the LBA and Lenny's Pizzeria for their substantial donations towards our fireworks.

Councilwoman Filippone thanked Council President Zalom for all the work she does with Memorial Day every year. The speaker was great and taps were right on.

Councilman Lamb stated that the Fire Company usually always donated trees to the Borough but they stopped recently because there was not any place to plant them. They would like to plant them at the back end of Philadelphia Avenue by the Bay and is requesting if Public Works could dig the holes for them.

Councilman Borowski stated that he would let Public Works know.

Councilman Stogdill reminded everyone that the Borough no longer uses a PO Box so everyone should use the mailing address of 1306 Grand Central Avenue when mailing your bills or correspondence.

Mr. Parlow stated that tomorrow, June 8th is the Primary Election and reminded all to vote.

EXECUTIVE SESSION:

Mr. George stated that there is a need to go into Executive Session for matters relating to contractual discussions pertaining to benefits. There may be possible action taken.

A Motion was made by Councilwoman Filippone to adjourn the Caucus/Regular Meeting to go into Executive Session. The Motion was seconded by Councilman Horan. All of Council was in Favor. The Motion passed. The Caucus/Regular Meeting was adjourned at 8:26 pm.

There was action that was taken which is to rescind Resolution 137A which was to join the State Health Benefits Prescription Plan. By rescinding this resolution the Borough of Lavallette will stay with Bollinger until further notice.

A Motion was made by Councilwoman Filippone to approve Resolution #172B which will rescind Resolution 137A. The Motion was seconded by Councilman Horan. Vote: Council Members Borowski, Filippone, Zalom, Stogdill, Horan and Lamb voted Yes. The Motion passed.
