MAYOR'S WELCOMING STATEMENT: Mayor LaCicero thanked everyone for coming out to the meeting tonight. He stated that there are some sixth graders in the audience that are receiving a Proclamation for the great job they did with winning 2nd place with the Disney Planet Challenge.

PROCLAMATION – Lavallette Elementary 6th Grade Science Class with Mrs. Lorenz-Mayor LaCicero read aloud the Proclamation and pictures were taken with the children, the teachers and Mayor LaCicero.

Dr. Peter Morris, the Superintendent of the Lavallette Elementary School thanked the Mayor and Council for all their support of the school. It is much appreciated.

street. Mr. Parlow stated that the CDBG program is on a fiscal year so the Borough cannot award a contract to purchase the mats until July 1st. The bid opening is scheduled for June 15th. Mr. Parlow requested that a special meeting be held for July 1st in order to approve the contract so that the mats can be delivered as soon as possible.

Mayor LaCicero stated that it was just pulled from the consent agenda and put on the off consent agenda so it could be voted on separately.

Councilman Lamb questioned what steps have been taken to make sure this does not happen again. Mr. Parlow stated that the new computer program used by the construction department provides monthly reports of all CO's issued. He stated

that he will personally hand deliver them to the Tax Assessor. There also is a ledger kept to document each one that comes in.

Councilwoman Filippone stated that she believes that is a violation of our Ordinance. Mr. George stated that the Ordinance states no ball playing on beach at all times or any other activity. Mayor LaCicero questioned if we should modify the Ordinance so this can be approved. Councilwoman Filippone stated that if we do approve this are we setting ourselves up for a liability issue. Mr. George stated that the Borough should get a clearance letter from Scibal Associates before approval. Councilman Lamb stated that we should not approve this we should just keep the one that is already up there. Councilwoman Filippone stated that was not approved by us either. Councilman Borowski stated that we should leave everything the way it is. If they choose to play then it is on them. Councilwoman Filippone stated that we have an Ordinance that does not allow some things and yet these things are not enforced. If we are not going to enforce them then the ordinance should be rescinded. Mayor LaCicero stated that we could modify the ordinance to approve it only in certain areas as long as we have insurance approval. Let's deny the approval for tonight and work on modifying the ordinance. Mr. George stated that he agrees to defer the approval until the committee meets and makes decision.

- e) Lavallette Municipal Alliance/Kathy Mango, Director/requesting approval for all their events for the 2011 summer season/Received May 23, 2011-Mayor LaCicero stated that these are annually approved and are okay. Council President Zalom stated that these are the same activities as last year and thank you for your approval
- i) New Jersey General Assembly/Assemblyman David Wolfe/requesting the attendance at their Boat Safety Meeting being held on June 9th/Received May 27, 2011
- f) Christina Ramage/White Avenue/requesting a mobi mat be put on White Avenue because she is handicapped/Received June 2, 2011-Mr. Parlow stated that one of the mats will be place on White Avenue.

Councilman Borowski questioned if there have been problems with the lights being on after 10pm. Councilman Stogdill stated that the soccer field lights are always on. Mayor LaCicero stated that this is okay.

UNFINISHED BUSINESS:

Summer Events of 2011 and 2011 Ball field Schedule

Mr. Parlow stated that the list of all of the approved events was provided for the benefit of the events criteria committee.

Change a Child's World-Request to hold a 5K Race on July 24th from 6am to 10am-Map with course layout included

Mayor LaCicero stated that at the last meeting Council was not in favor of this but requested more information included a map layout and the time frame.

Mr. Parlow stated that the date they are requesting is July 24th, which is right in the middle of the summer season. The course would require the closing of Bay Boulevard along with the streets on West Point Island and Baltimore Avenue. He stated that Saturday is a turnover day for renters and he does not think the streets being closed is a good idea. He stated that the Borough should not have any marathons in July and August.

All of Council agreed that this event is not approved.

Councilman Borowski questioned if anything was discussed with the County about the crosswalk signs.

Mayor LaCicero stated that Mr. Parlow did find the letter from the County and they do not allow the pedestrian signs to be put on a divided road. Maybe we can see if we could put some type of signs out there to slow down the traffic.

Councilman Borowski asked if Council agrees to allow him to draft a letter to Freeholder Kelly who is in charge of traffic safety to evaluate that intersection and see if maybe they could do some type of three way stop.

Councilwoman Filippone stated that she has received a lot of complaints merchandise being display outside of businesses and other Ordinances that are not being enforced. She stated that if we are not going to enforce the Ordinances then they should be rescinded or certain items should be removed.

Councilman Borowski questioned if it is the domain of the Code Enforcement Officer to write summonses in violation of the display of merchandise ordinance.

Mr. George stated that yes the code enforcement officer has the authority to legally sign the summonses.

Councilman Borowski stated that the fence on Brooklyn Avenue Public Works is scheduled to be replaced on June 15th.

NEW BUSINESS:

There was no new business.

COMMENTS FROM THE PUBLIC:

Clem Boyers, 20 Kerr Avenue requested that the end of Bay Boulevard be left open during the race on June 25th. Club members are having problems entering the Yacht Club during the events.

Mr. Parlow stated that he will speak to the Chief.

Mr. Boyers stated that his wife takes care of the plantings in front of the post office and she said there were so many news racks and they take up so much space. He asked if there are any regulations as to where they can be placed and how many can be there at the same time.

Mr. Parlow stated that there are regulations and a fee. The Code Enforcement Officer goes out and checks to see what is out there and if they have paid. He also makes sure they are following the regulations. The racks should not be placed so many feet away from curb cuts and utility poles.

Judy Heim, 100 Bond Avenue stated that when she was growing up in Lavallette there was always a volleyball net on the beach adjacent to White and Kerr Avenues. They did change the times and we could only play after 5pm. They decided we should not play during the day.

Mayor LaCicero stated that would be something to think about.

Mrs. Heim stated that instead of donating wreaths for Memorial Day maybe we should consider the donations of trees and shrubs and they could be placed on the sides of Memorial Park to give it more shade.

Mayor LaCicero stated that they will check with the Gardener and see what he suggests.

Joe Palinsky, 122 Washington Avenue questioned why Council can just not permit any events from Memorial Day to Labor Day.

Mayor LaCicero stated that is why we created the committee to discuss the problems and come up with suggestions.

Mr. George stated that approving some events and not others starts to become tricky. This is a place of public resort and denying the public is not really a good idea. You could however only approve a certain number of events during the summer either by a lottery or pre registration. These are ideas that the committee can discuss.

Mr. Parlow stated that the use of our facilities always needs approval.

Mr. Palinsky stated that there is a patch of green at the southeast corner of Philadelphia Avenue and Bay Boulevard that is full of debris and should be cleaned up a bit. He suggested that the gardener take a look and maybe clean it up a bit.

Councilman Borowski stated that he does not think the First Aid owns it but they have taken care of it in the past.

Mr. Palinsky stated that the type of plantings that are there are bayberry bushes and they collect garbage.

Mayor LaCicero stated that we would have the gardener take a look at it.

Councilman Borowski stated that he believes that they tried to change the plantings there once before and received flack from an Environmental Group but he would speak to the gardener.

COMMENTS OF THE MAYOR AND COUNCIL MEMBERS:

Councilman Stogdill thanked Council for approving the senior wooden-bat league.

Councilman Lamb stated that we should thank Joe Baginski for taking control again. He is doing a great job.

Councilman Stogdill stated that they still volunteers to work the snack stand so if anyone is interested they should contact the League.

Councilman Borowski stated that he would not be at the next meeting because he is going on vacation.

Council President Zalom thanked Council for the approval of the Municipal Alliance events.

Councilman Horan thanked Council President Zalom for Memorial Day Services.

Councilwoman Filippone stated that the white shirts on the Police look fabulous.
