READING OF THE OPEN PUBLIC MEETINGS ACT STATEMENT: Notice of this meeting complies with the Open Public Meetings Act. Public Notice was given to the Ocean County Gazette and was published in the Ocean Star on January 7, 2011. Notice was also posted on our Municipal Website and the Municipal bulletin board.

MOMENT OF SILENCE: The Mayor asked for a moment of silence for the thirty American soldiers that were killed in Afghanistan.

PLEDGE OF ALLEGIANCE: Councilman Stogdill led the Salute to the Flag

MAYOR'S WELCOMING STATEMENT: Mayor LaCicero thanked everyone for coming out to tonight's meeting.

COMMENTS FROM PUBLIC: (Items not listed on Agenda/not staying for remainder of meeting)

The Mayor asked if anyone wished to comment on any items that were not listed on the agenda and that they did not wish to stay for the remainder of the meeting they could do so now.

Bob Storch, 1507 Baltimore Avenue questioned when his road was going to have the additional 25 feet of yellow lines removed. He stated he sees that on some other streets it has already been done and was told that his street would be done before the summer.

Councilwoman Filippone stated that she believes that the additional streets will be completed in the fall but she will check with the Chief.

He stated since we increased the daily badge price to \$7.00 we have had record sales with the season badge which increases our revenue tremendously.

Save Barnegat Bay is looking for our donation so she will send them a check from the Council for \$30.00 and the Council can pay her back.

Mr. George stated that in this situation it was the Borough's plows who they claim damaged the curbs so it would have to be sent to our insurance company. With your situation since it was a private contractor you would put a claim in with his company for the damages.

UNFINISHED BUSINESS:

Council President Zalom stated that on New Jersey Avenue and the Ocean there is a new house there and the driveway is encroaching on the other property.

Councilman Horan stated that was all taken care of already.

Councilwoman Filippone stated that she would like Council to give her any of their suggestions about the Ordinance changes on the issues that have been discussed such as the display of merchandise, no solicitation, smoking on the beaches and the garbage can and lid problems. Once she gets some suggestions she will call a meeting of the Ordinance Committee to discuss possible changes.

Councilman Borowski stated that he received comments from both sides of the fence on the selling of things on the boardwalk. Some parents were appalled that we were not allowing their children to do the shells or lemonade; he stated that he also heard from some beachgoers that it is nice not to have them there in the pavilion because now they can sit down and get their beach stuff together.

NEW BUSINESS:

Councilman Lamb stated that he has received a lot of complaints about the balls hitting some houses and windows from the ball field. They really want something to be done about it. We need to get some type of netting on both sides to prevent the balls from entering the roadways.

Councilman Stogdill stated that he has received some complaints also and suggests some type of netting on maybe the Jersey City Ave side and the Baltimore side.

Council President Zalom stated that she gets complaints about the basketball courts not being fenced in.

Councilman Borowski stated that he thought the Little League was going to revamp the snack shack to incorporated bathrooms in there.

Council President Zalom stated that she received a check from Tom Tevlin again thanking us for a wonderful Memorial Day Services. Doug Houser is a resident in town as well as a teacher and he is running the CSI Camp at the school this year. He recently used our bus to take the kids down to the bay and was very appreciative for that.

Mayor LaCicero stated that he has a problem with the big yellow signs about junk cars on our telephone poles.

Mr. George stated that the telephone poles are the property of Lavallette and there should be no signs in the right of way.

Councilwoman Filippone stated that this is why we need to make the ordinance stricter restricting the number of signs that are allowed.

Council President Zalom questioned whether we could just limit the signs to just having town approved signs only.

Mr. George stated that the language is very limited but the submission is permissible. He stated that he will research and let us know.

COMMENTS FROM THE PUBLIC:

Mayor LaCicero opened the floor to public comments.

Herb Hascher, 1301 Bay Blvd stated that he witnessed a golf cart going up and down the road all weekend and thought we had an ordinance not allowing low speed vehicles in Lavallette.

Mayor LaCicero stated that we do have an ordinance banning the low speed vehicles.

Councilwoman Filippone stated that if Mr. Hascher sees anymore low speed vehicles again he needs to call the police immediately so it gets taken care of right away.

There were no additional comments from the public.

Mayor LaCicero closed the floor to public comment.
