READING OF THE OPEN PUBLIC MEETINGS ACT STATEMENT: Notice of this meeting was published in the Ocean Star on January 8, 2016. Notice was also posted on our municipal bulletin board and municipal website.

MOMENT OF SILENCE: Mayor LaCicero asked for a moment of silence for anyone who has lost a loved one.

PLEDGE OF ALLEGIANCE: Councilman Stogdill led us in the Salute to the Flag.

MAYOR'S WELCOMING STATEMENT: Mayor LaCicero thanked everyone for coming out to tonight's meeting. He stated that we have a resident in our audience tonight that had a birthday recently and has made it to 100 years old.

PROCLAMATION: Barbara Jost-100 Years Old

Barbara Jost resides on West Point Island and has for many years. She has just turned 100 years old and we have a proclamation for her.

Mayor LaCicero read aloud the Proclamation.

Mrs. Jost stated that she loves the new Municipal Building and loves Lavallette. She found this town by accident after her house she was renting in Pt. Pleasant Beach sold. She is very glad she did find it because it has brought her nothing but joy to live here.

The Mayor stated that if anyone wished to comment on any items that were not on the agenda or if they could not stay for the remainder of the meeting they could do so now.

COMMENTS FROM PUBLIC (Items not listed on agenda / not staying for remainder of meeting)

David Duffy, 1 Dover Avenue stated that he was unable to attend the last meeting so he would like to speak about the beach access tonight. He resides at 1 Dover Avenue and has owned it for numerous years. His concern has always been the danger of not having all the streets open **to the**

public. If there is a thunderstorm and lightning is present, if all the people cannot get off that beach as quickly as possible there is more of a chance of people getting hit by lightning. He owns a funeral home and he had a 23 year old last week that was hit by lightning and died. It does happen and there is more of a chance with restricted access. This whole situation is all monetary but lives are not.

Mayor LaCicero stated that it is not at all monetary for us up here. He understands it is a big issue for some residents but not for all. The replenishment project is starting next year.

Mr. Duffy stated that he also would like something done about the street lights on Dover Avenue that have not been working for months. He also would like to be aware ahead of time that there is going to be discussion on the replenishment project and/or the beach access. Can any discussion that is going to take place at a meeting be put on the agenda so we are aware of it.

Mayor LaCicero stated that he will make sure it will be put on the agenda if there is going to be any discussion on those subjects and he will advise Public Works about the street lights.

Bill Brannick, 2 Dover Avenue stated that he has been coming to Lavallette for 60 years with his family and there has always been access to the beach on every street up until Sandy hit. Why was the decision made to restrict the access?

Mayor LaCicero stated that it was to protect the homes and the town from another storm.

Mr. Brannick stated that Dover Avenue has no dunes still so what protection are you preventing for that street?

Mayor LaCicero stated that there were dunes there because we paid a lot of money to put them there.

Mr. Brannick stated that he has lost a lot of rentals because of the restricted access and he believes the value of his house has gone down because of it. He is getting a lawyer to appeal his taxes and he believes he can get 100 more people to appeal their taxes for the same reason.

Mayor LaCicero stated that he has the right to appeal his taxes and if he feels his value has decreased then he should go through that process.

Councilman Borowski stated that this ordinance is needed for the next step to process legislation that has been worked on for the last four years. This will eliminate restrictions and get into more aggregate purchases and keep rates low. There will be an introduction tonight and if the legislation goes through before September 19th we can have the public hearing and final adoption. If it doesn't, we will go ahead with the public hearing and carry the adoption.

Councilman Finter stated that even with that increase there is still no increase in our cost which hasn't changed since last year.

Council President Zalom stated that we always save a lot of money for our residents with this program so we want to keep it going. Councilwoman Filippone questioned if the Mayors along the barrier island were still looking into joining together and getting an outside agency to do the CRS Program? Mayor LaCicero stated that our meetings have halted until September but we were discussing it but not sure if we made a definite decision as of yet.

- e) Kris Kennedy Scuorzo/4 Brooklyn Avenue/requesting the board reconsider suggestion to re-open the boardwalk to bike traffic after the beaches close at 6pm/Received July 29, 2016-Councilman Borowski stated that bicycle safety is extremely important especially in Lavallette. He was hit by a vehicle while he was riding a bike when he was 16 years old and he was hurt very seriously. He was following the rules but was still hit by a vehicle. Bikes are already allowed on the boardwalk in the morning hours before 10am. Having them up there after 6pm after the beach goers have gone and the lifeguards have completed their days sounds sufficient to me. We need to start trying something different with these bicycles. He spoke with the Chief and he is in agreement with it and he assured me he will put the bike cops up there and monitor the situation to see how well it is going. He feels that the hours of 6pm to 10pm seems like a good time frame for a trial period. Council President Zalom stated that 20 or so years ago the Police Chief at that time always told people to ride the bikes on the boardwalk because the highway was too dangerous. Bikers and walkers up on that boardwalk before 10am is also too dangerous and way to congested. Maybe if people were made aware they can ride the bikes up there after 6pm they wouldn't rush up there to do it before 10am and it will prevent less congestion. Councilwoman Filippone stated that if it was possible for the Police Department to enforce bike safety rules we wouldn't be having this issue. None of the bicyclists in this town that I have witnessed follow any of the rules. The police have more important things to take care of in this town than to watch the bicycles. This issue is always split down the middle as far as residents who are for the boardwalk and not for the boardwalk. We spent a lot of money for a bike path on Bay Blvd. for the bicyclists and it is the safest way for them. Just because it is not ideal for them and they choose not to utilize it is not the Borough's responsibility to figure out another solution. We already did that and spent money to do it. The Police don't write tickets to them now so why would they do it on the boardwalk. Councilman Finter questioned if they could just give them warnings and no tickets. Councilwoman Filippone stated that was also tried years ago. We give our bicycle safety rules out to every person that purchases a badge in Lavallette so they know the rules they just choose to not abide by them. Council President Zalom stated that the problem is that with our angle parking on the highway riding a bicycle behind those parked cars is extremely dangerous when cars are trying to pull out. Councilman Lamb stated that he has lived here his whole life and the bicycle safety is nothing new since he was a kid. When I was a police officer here we use to confiscate bikes if they didn't follow the rules and that never worked either. Riding bikes on the highway has never been a good idea in Lavallette since I was growing up here in the sixties. My mother use to make us put our bikes in the garage for July and August every year because it was so dangerous so it has always been this way. There is not enough room up on the boardwalk for walkers and bikers at any time of the day and it is too dark to see anything up there in the evening. Councilman Finter stated that he doesn't see it as an issue at all and we should at least try it from now until Labor Day to see how it works out. Councilman Stogdill stated that we were only allowed to ride our bikes on Bay Blvd. growing up here in the summer and if we were seen on the highway or any place else with them we were in trouble. Councilman Borowski stated that he would like to allow the audience speak now on this issue and give their opinions. Herb Hascher, 1301 Bay Blvd. stated that Bay Blvd. is a great place to ride the bikes and as long as everyone follows the rules there should be no issues.

Council President Zalom stated that in Miami their bike lanes are painted green in the busy sections and she is going to suggest to our legislators that New Jersey do the same thing so everyone sees them.

Clem Boyers, 20 Kerr Avenue stated that we have two great bike lanes on Bay Blvd. and one on Route 35 North. The badge checkers use the boardwalk with their bikes and they even have to go on the highway sometimes because it is too congested. Day or night the boardwalk is also too dangerous for bikers.

Mary Logios, 4 Sterling Avenue stated that she is in agreement as far as not having the bikes on the boardwalk because of too much congestion. Also, the police never write the summonses for not following the rules.

Conrad Brink, 122 New Jersey Avenue questioned is it a boardwalk or a boardride? That should say it all.

Jon Corney, 1 Newark Avenue stated that the problem is the enforcement of the rules. If the Police enforced the rules and ticketed every person that did not follow the rules then maybe we wouldn't have such an issue.

Alita Taylor, 1202 Ocean Front stated that bikes on the boardwalk is not a good idea at all. People will get hurt if that is allowed. The Police on the bikes have no bells or lights on their bikes and that is dangerous also. There really needs to be something done about the bikes going the wrong way on the highway because the cars only look one way for cars and if a bike is going the other way they will collide and it happens all the time.

Kris Scuorzo, 4 Brooklyn Avenue stated that she is the reason for this discussion. Her only concern is the safety of the children. The bike lane on the highway is in no way safe enough for children to ride on it because of the angle parking and cars backing up. She has been monitoring the amount of pedestrians on the boardwalk after 6 pm and it has decreased tremendously and there is police presence on the boardwalk. She just wants to be able to make it safer for the children to ride their bikes.

Councilman Borowski stated that we now have a good feel on opinions both positive and negative and change is never really easy. He would like to make a motion to allow the bicycles on the boardwalk between the hours of 6pm to 8pm from now until Labor Day and continue to monitor it.

A Motion to allow the bicycles on the boardwalk from 6pm to 8pm from now until Labor Day was made by Councilman Borowski. The Motion was Seconded by Councilman Finter. Vote: Council Members Borowski, Zalom and Finter voted Yes. Council Members Filippone, Stogdill and Lamb voted Yes. This has created a tie. Vote: Mayor LaCicero voted No. The Motion has Failed.

Mayor LaCicero stated that he was a Police Officer for 25 years and this has always been an issue. He just has never been comfortable with the boardwalk and the bikes.

- f) Robert Brady/51 Pershing Blvd./requesting that the Borough update the Bocci Ball Courts with an all-weather felt surface/Received August 5, 2016-Mayor LaCicero stated that he doesn't think that this surface is a traditional surface for public courts.

UNFINISHED BUSINESS:

John Bennett-Discussion of Water Tank Repainting Grant Application

Mr. Bennett stated at the last meeting they approved this application for \$2,500 and he has now been told that there was a typo and it is \$25,000. With this grant there is potential for partial loan forgiveness but not a definite. The work for this application process was already in progress before this approval was given. Councilman Borowski and myself have already talked about it and he has reached out and received some data that suggests that \$25,000 is not so off for this type of application process and the work needed to be done to start it. We do have the money in the water department where we would be taking it from.

Mayor LaCicero stated with some of the application already processed on line how can we deny it.

Councilman Borowski stated that he did check with other firms and this is not an unreasonable sum and is the going rate for this type of work. He also was told that it is mandatory to make sure that all the contracts are gone over concerning the cell towers and make sure we will not be responsible for any costs associated with the removal of their equipment.

Mr. George stated that if the services are under \$17,500 it won't have to go out for bid for those services. If they are over \$17,500 depending on if we have a QPA or not the bid thresholds are different.

Mr. Bennett stated that a punchlist was given to Wallace regarding the lifeguard building. The only issue that still will need to be addressed is the flooring. We are unsure who is responsible regarding the flooring whether it is from the design or the installation so we are waiting until after Labor Day to deal with that issue.

Mr. Bennett stated that the training regarding the heating and air conditioning went well but we are still experiencing some issues that we will have to take care of.

Council President Zalom stated that the Engineer was getting proposals for the municipal building entry door. We are trying to make it more handicap accessible. We are trying to get approval to use the rest of the 2015 CDBG funds for this. As long as it is an old building and not a new one. Well it is now an old building because it is already being used so they are confident that we will be approved for this project. Also, she attended the workshop for the Arts Grant that we apply for every year for our concerts. We also discussed getting a grant for our memorabilia in the building so we will be applying for that grant also.

NEW BUSINESS:

Mr. Bennett stated that we paid \$5,000 a year for a bus that Seaside Heights has that would take barrier island residents over the bridge. We haven't used this bus for many years because of the Ocean Ride bus so we will no longer be paying this annual fee. He attended a meeting regarding the Mathis Bridge coming over from Toms River and its mechanical issues. We were told by the State and the contractor that the issue will continue because the bridge is extremely old and should have been replaced instead of repairing. We worked out some issues as far as contacting surrounding towns when the issue is longer than 15 minutes so the traffic can be diverted. The Coast Guard has the bridge going up every half hour for the boats but the State was going to try and reach out to them to see if we can get permission to open it every hour instead because the problem only occurs when the bridge has to open. We feel that it has become an emergent situation for the traffic of the cars compared to allowing the boats to cut through.

Councilwoman Filippone stated that when this issue of the repair of the bridge was first being talked about we as a town took action and requested that the bridge be replaced instead of repairing because of all the issues it had and the age of it.

COMMENTS FROM THE PUBLIC:

Joe Palinsky, 122 Washington Avenue stated that the water tower was repainted before about 7 or 8 years ago and at that time there was talk that the cell antennae was the cause of the issue.

Councilman Borowski stated that most of the repairs this time are interior issues and not so much exterior.

Clem Boyers, 20 Kerr Avenue stated that he has seen the bike Police and they seem to have lights on their bikes this year. All bikes are supposed to have lights and bells on them while being used.

Mark Speaker, 111 Brown Avenue stated that as far as the bridge issue with the notification of when it is down, could maybe the use of the emergency notification system that we have be utilized when you are notified of it being down. A lot of our business owner's employees get stuck and can't come over so it would be nice if we new it was down ahead of time so we can notify them in advance.

Mr. Bennett stated that can be looked into.

COMMENTS FROM THE MAYOR AND COUNCIL:

Councilman Stogdill stated that the shed was purchased for lifeguard headquarters. It's a 14 ft. shed that is replacing the small trailer that is there now housing their equipment. Also, he will need to be excused for the next meeting.

Councilman Borowski stated that he will need to be excused for the next meeting as well. Waves of Impact held their surf camp for the disabled children on July 27th and it was a big **hit once again**.

This is always a magnificent event and is held all over the world. They inform me every year that the Lavallette staff and people are the most welcoming and they love to come here the best. They also presented a plaque to the Borough of Lavallette for all the help that is provided from our beach staff.

Councilwoman Filippone stated that she will be speaking to the Chief about the lights and bells being on the bicycles the Police use. She believes it is a State statute so it is very important. If a police officer gets a call and needs to get there as soon as possible he has the right to go the wrong way with the back but he still needs the bell and light on his bike. She will be looking into getting some temporary blinds for the windows in Council Chambers due to the sunset at this time of the year which puts a damper up here with being able to see our computers. Regarding the access ways to the beach we have had these restricted access ways since after the storm to prevent any damage to the homes. After sandy, this town was completely devastated. Each time you cut through a dune it weakens the dune system, especially at the south end of the town. We are very specific in protecting our dunes as far as the sand and the dune grass. The root system entangles like a vine and holds everything together and makes the dunes big and strong enough to withstand the weather. This beach replenishment project will not cut through the dune they will be going up and over the dunes.

Council President Zalom stated that the dune system at the north end of the town held so much better than the south end during sandy. We did not create those dunes, the dune system just keep growing and made those dunes big and strong. The integrity is in the dune grass and the dune system. Regarding the Army Corps. permit for the dredging under the WPI Bridge it will expire on December 31, 2016 and the DEP Permit has already expired. We will need to apply for both of these permits again in order to do any dredging there.

Mayor LaCicero stated that we are going to need two proposals from the Engineer on how much these two permit applications will cost us.

EXECUTIVE SESSION:

There was no executive session.


