# BOROUGH OF LAVALLETTE(minutes) CAUCUS/REGULAR MEETING OF THE MAYOR AND COUNCIL LAVALLETTE MUNICIPAL BUILDING Tuesday, July 6, 2021-7:00 pm

CALL TO ORDER: Mayor Walter G. LaCicero, presiding

**READING OF THE OPEN PUBLIC MEETINGS ACT STATEMENT**: Notice of this meeting was published in the Ocean Star on January 8, 2021 Notice was also posted on our municipal bulletin board and municipal website.

**MOMENT OF SILENCE**: The Mayor asked for a moment of silence for long-time resident George Kelly, Bond Avenue who passed away and for a very long time resident Dick Hoffman who was also our Beach Lifeguard Captain many years ago.

**PLEDGE OF ALLEGIANCE:** Councilman Finter led us in the Salute to the Flag.

**MAYOR'S WELCOMING STATEMENT:** The Mayor welcomed everyone to tonight's meeting. He stated it was a very interesting 4<sup>th</sup> of July weekend and there were a ton of people here. The patriotic bike parade that took place this weekend had the largest number of participants since the event started a few years back.

Council President Zalom stated that the first concert of the season was last weekend and there was an extremely large attendance as well as this weekend's concert.

The Mayor stated that the amount of participants this weekend using our pickleball courts was unbelievable as well.

## **UNFINISHED BUSINESS:**

**Substantial Damage Assessments** 

Mr. Brice stated that there is still a number of current homes in Lavallette on the list from the State for substantial damage. The State sent all municipalities guidelines on June 30<sup>th</sup> of how to proceed with determination on whether these homes were put on the list for erroneous reasons or if they truly sustained this damage and should remain. The first step is for the homeowner to appeal to the Planning Board if they want to be removed from this list.

#### **NEW BUSINESS:**

Mayor LaCicero stated that he received a lot of calls regarding these electric bikes. They seem to be able to go at a high rate of speed to be on the boardwalk and on our streets. There seems to be a lot of them in town this summer and they are not taking any precautions while using them.

Mr. Brice stated that these bikes are really silent but deadly and are limited to 25 mph but the ones in town don't seem to be following those rules.

Councilwoman Filippone stated that these should already be included under our slow speed vehicle ordinance.

Mayor LaCicero stated that he would like our Attorney to look into it and either add it to our current ordinance or create a new section for them. Maybe not ban them but definitely restrict them to the streets to only 25 mph and not allowed on the boardwalk or sidewalks at all.

### **COMMENTS FROM THE PUBLIC:**

Matt Schlosser, 241 Newark Avenue, stated that he is here as a member of the WPICA and stated that they are concerned about kids chucking the rocks into the water that are located on the south side of the WPI Bridge and was wondering if those rocks belong to the County or the Borough because they really need to be netted down to prevent the kids having access to them.

The Mayor stated that the bridge itself is County but the waterway is the State. We already have issues with the dredging in that area so we definitely don't need this issue on top of it. Maybe the County can put some type of mesh covering over the rocks to prevent access to them.

Mr. Brice stated that maybe some type of chain link fence.

Mr. Schlosser stated that the WPICA is also willing to help out with this as well.

Councilman Borowski questioned if security cameras should be put in that area as well.

Mayor LaCicero stated that we can look into that as well.

Mr. Brice stated that we are going to be putting some mobile cameras in the gazebo and bay front areas due to the continued vandalism in that area so we can probably put them in that area as well.

Council President Zalom left the meeting at 7:55pm.

#### COMMENTS OF THE MAYOR AND COUNCIL MEMBERS:

Councilman Borowski stated that July 29<sup>th</sup> Waves of Impact will be on the Trenton Avenue Beach with the disabled children surf camp. He also wanted to congratulate Mike Visco on his retirement but is sad for the Borough because he was a remarkable employee and always **going above and** beyond with his job as gardener and doing a great job with the plantings in front of our building and

along the bay front. He will be truly missed. He also wanted to mention Bob Baker. He was a great employee and always did a great job. He thanked the Emergency Cert. Team for helping with traffic control during the concerts and any events they are needed.

Councilwoman Filippone stated that she thinks it is time again to send a letter to the DOT regarding these pedestrian crosswalks. The lack of cooperation with drivers and pedestrians is so horrible.

Mayor LaCicero stated that we can have the Attorney draft a letter.

Councilwoman Filippone stated that she also would like some type of pa system for the up at the beach to play the National Anthem every morning. She knows of a few towns that do it.

Mr. Brice stated that we had a discussion with the DOT regarding the issues with the crosswalk traffic on President Avenue and Rt. 35 North and the amount of issues we have there with drivers and pedestrians. They offered to do a cost share program with us 25/75 for a flashing beacon. Also, there has been a lot of issues with controlling parking on the west side of Bay Blvd. and we will be requesting the County to paint yellow on the curb in that area to prevent any kind of parking. We are also having a big problem with the garbage cans being way over the weight limits. They are just too heavy for our guys to pick up. The weight limit is in our code so if it is too heavy they will now be issuing warnings and tickets.

#### **EXECUTIVE SESSION:**

There was no executive session.

#### **ADJOURNMENT:**

A Motion to adjourn the Council Meeting was made by Councilwoman Filippone. The Motion was Seconded by Councilman Finter. Vote: All of Council was in favor. The Motion Passed.
