Application 13-18: Jay Bea Condominium Association, 1806 Grand Central Avenue, Block 45.01, Lot 4 – Minor Site Plan

Mrs. Donato, applicants' attorney, is requesting minor site plan approval and wished to address the comments in the October 31, 2018, First Engineer Review letter.

Christopher Burchell, president of the Jay Bea Condominium Association was sworn in and gave testimony regarding:
