FORM & FEE:

Must accompany all reservations. Exhibitors MUST submit 3 photos of their display and work. Preferences will be shown to the most attractive presentation. Checks will be returned if Committee does not select entry. **ALL ENTRANTS** MUST INCLUDE A PHOTO COPY OF NJ STATE SALES TAX CERTIFICATE.

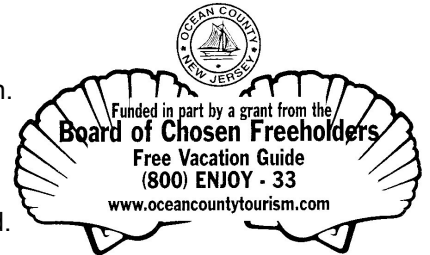
SELF ADDRESSED STAMPED ENVELOPE:

MUST BE INCLUDED for confirmation, assigned space allocation and photo return.

RAIN DATE:

If the weather permits a set-up and **2 hours** of selling. **NO** RAIN DATE will be offered.



RULES:

Free standing displays, white canopies and umbrellas are encouraged. NO CARS or VANS may remain on the grounds. All vendors **MUST** PARK on Baltimore Avenue in reserved Vendor Parking Area ONLY. Failure to comply will be subject to POLICE INTERVENTION. Vendor must display original NJ Sales Tax Certificate in display at all times.
