MOMENT OF SILENCE: The Mayor asked for a moment of silence for Daniel Rizzuto, a resident on New Brunswick Avenue that passed away and for all our troops overseas.

PLEDGE OF ALLEGIANCE: Councilwoman Filippone led us in the Salute to the Flag

MAYOR'S WELCOMING STATEMENT: The Mayor thanked everyone for coming out to tonight's meeting. He stated that the coming summer season our highways will not be obstructed. He and Mr. Parlow attended a meeting with the NJ DOT and were assured that from Memorial Day to Labor Day the highways travel lanes will not be obstructed and that no work will be performed on any portion of the roadway from Brown to Bond Avenue, which is the B2 district. He asked if anyone wished to comment on any items that were not on the agenda or if they could not stay for the remainder of the meeting they could do so now.

2014-67

authorizing a second special emergency appropriation in the amount of \$700,000 as an amendment to the original special emergency appropriation adopted November 20, 2012 to provide funds for response to the extraordinary expenses resulting from damage caused by super storm sandy and further authorizing the issuance of special emergency notes to fund such special emergency appropriation-Mr. Parlow stated that right after the storm the Council adopted a special emergency appropriation in the amount of \$4,000,000. The funds were needed to pay for the emergency costs associated with Sandy. The governing body also entered into an interlocal service agreement with the County of Ocean for debris removal. The County would act as a financial broker and pay the invoices associated with the debris removal. The total of those costs were in excess of nine point two million dollars. Lavallette is responsible for the ten percent share of those costs, which amount to nine hundred and twenty one thousand dollars. Up until this point the Borough has already spent over three point five million of the four million dollars appropriated, leaving a balance of under five hundred thousand. In order to pay the balance owned to the County we need to modify the emergency appropriation; adding an addition seven hundred thousand dollars. This will allow us the pay the County and continue to pay other non-capital Sandy expenses; such as the monthly temporary trailer expenses. The County invoice is due in June of 2014. The State has provided pre-approval of this modification and has also discussed the possibility of paying the municipalities ten percent share. Mayor LaCicero stated that most of the money that was spent has already been reimbursed by FEMA but we can not reimburse the appropriation line item. The funds that we received from FEMA must be deposited in a reserve to pay the emergency notes. Councilman Borowski questioned if the \$3.4 million that was received from FEMA will be used to pay off the special emergency. Mr. Parlow

stated that it will be used to pay off the special emergency as well as the emergency bonds.

- establishing the beach badge preseason Beach Badge Office hours for the 2014 summer season and establishing the official summer beach opening day-Mr. Parlow stated that 2014 will be a ten week summer with Labor Day being September 1st and opening day is June 21st this year.
- authorizing a budget transfer within the current fund in the amount of \$6,500.00-Mr. Parlow stated that the Beach Captain wanted to get a head start with his expenses and the Fire Dept. needed a correction on one of their line items from the storm.
- authorizing a budget amendment in the amount of \$30,000 for the Strategic Recovery Planning Grant-Mr. Parlow stated that this is a grant we received for going through our ordinances and we had the kickoff meeting already.

A Motion was made by Councilman Horan to approve the consent agenda. The Motion was seconded by Councilman Stogdill. The Mayor opened the floor to the public and asked if anyone wished to comment on the consent agenda. No one wished to comment at this time. Mayor LaCicero stated that we have someone who is licensed as an Animal Control Officer and has offered to donate their time to help. In order for that to happen we had to create the position of Assistant Animal Control Officer and also with this new zoning grant they will pay for any assistants that we will need in the Zoning/Code Enforcement Department.

Councilman Borowski questioned if those positions are covered by Civil Service.

Mr. Parlow stated that they are.

The Mayor opened the public hearing and asked if anyone wished to comment on this ordinance. No one wished to comment. - A4464/Received January 17, 2014-Mayor stated that he will have to check out the bill. Councilman Borowski stated that the bill requires everyone that is involved with a motor vehicle fatality should be blood tested for alcohol or drugs and also if they are inattentive. Mr. Bernstein stated that the bill he is referring to in his letter, which was sent out to a number of towns are expired and were part of the last legislative session.
- Timothy E. Furey, Jr./10 Princeton Avenue/requesting relief with water, sewer, electric and taxes on his property due to super storm sandy/Received January 22, 2014-Mayor LaCicero stated that he has been looking into this problem. Apparently, there is still a boot on the electric meter, the sewer and water is still in tact. He should have requested a disconnect right after the storm so he would not get any bills. As far as the taxes we did lower his dwelling assessment but we are not lowering any land assessments right now.

UNFINISHED BUSINESS:

Councilman Borowski apologized for his absence at the last Council Meeting. He stated that he read in the minutes that some members of the Fire Company attended and were looking for an update on the fire house renovations. He asked if Mayor LaCicero could give him another update.

Mayor LaCicero stated that Waves for Water were looking into trying to fund the whole project for them but they were having issues with the amount of money it would cost to move the kitchen where the Firehouse wants it to go. He stated that he spoke to the President of the Fire house again and he said that if that is all that is holding it up maybe the kitchen can stay where it is.

Councilman Lamb stated that Waves for Water was looking to give ten or twenty thousand which is still not going to be enough for the repairs it needs. He stated that he still thinks we need to go out to bid or at least get some type of estimates to see where we are at with prices.

NEW BUSINESS:

Councilman Borowski stated that in the minutes he also saw a request for a refund on a gazebo rental. He suggests that maybe in the future we look into amending the ordinance and not give refunds anymore with all the administrative work that is associated with a refund and the cleaning of the grounds. He recommended that the fee should be non refundable.

Mayor LaCicero stated that maybe we can do that during our budget process.

COMMENTS FROM THE PUBLIC:

Mayor LaCicero opened the floor to public comment.

Clem Boyers, 20 Kerr Avenue stated that he received his flood insurance bill and he received a twenty percent discount. He thanked the Borough for their participation in the CRS program.

Mr. Parlow stated that last year the discount was ten percent, but this year it was raised to twenty percent.

Mayor LaCicero stated that he believes we get one of the highest discounts in the state.

Councilman Borowski questioned what that saves us as a whole town?

Mr. Parlow stated that he believes the savings are nearly six hundred thousand per year.

Mr. Boyers stated that he appreciates all the work that everyone one does for the residents.

Joan Brackman, 10 Pennsylvania Avenue questioned if there was any decision on how many walkovers that were handicap accessible were going to be put on the beach.

Mayor LaCicero stated that we asked for two walkovers that were handicap accessible and we also sent all the requests that the residents did through the website over to them.

Ms. Brackman questioned if there was going to be a garage sale and cleanup this year.

Mr. Parlow stated that there will be no garage sale as per Municipal Alliance and there has been no decision on the cleanup days yet.

Joseph Palinsky, 122 Washington Avenue stated that people should be monitoring the dewatering associated with the highway project and should pay extra attention to their evergreens. He commented that the plants look like they are dying.

Councilwoman Filippone stated that she thinks that the plants are dying this year because of the storm last year. She commented that all of her evergreens that survived the storm are dying this year. All that shrubbery took a lot of abuse and she thinks it just caught up now.

Al Jones, 113 Reese Avenue questioned if the Borough could let the residents know on the website what streets are closed each day. It is becoming a hassle to try and get where you need to go anymore.

Mayor LaCicero stated that unfortunately the Borough does not receive notification of when each street will be closed.

COMMENTS OF THE MAYOR AND COUNCIL MEMBERS:

Mayor LaCicero stated that he met with the contractor, Harms, and the NJ DOT about the spring season and about consolidating their construction equipment and trucks so that some properties and streets do not look like a construction yard since more homeowners will be coming down to get their houses ready for the summer.

EXECUTIVE SESSION:

Mr. Bernstein stated that there is a need for an executive session regarding a PBA grievance. There may be action taken at this time.

A Motion was made by Councilman Horan to adjourn the Caucus/Regular Meeting to go into Executive Session. The Motion was seconded by Councilman Stogdill. Vote: All Council was in favor. The Motion Passed.

The Caucus/Regular Meeting was adjourned at 7:47 pm.

A Motion was made by Councilman Stogdill to reconvene the Caucus/Regular Meeting. The Motion was seconded by Councilman Horan. Vote: All of Council was in favor. The Motion Passed.

The Caucus/Regular Meeting was reconvened at 8:18pm.

Mr. Bernstein stated that Mayor LaCicero and Councilman Lamb recused themselves from the Executive Session due to a conflict and Council President Zalom is on vacation so Councilwoman

Filippone presides. Christian LaCicero, President of the PBA presented the case regarding a Step 4 grievance because of a step increase withheld.

Mr. Bernstein stated that his recommendation is to deny the grievance.

A Motion was made by Councilman Horan to deny the grievance. The Motion was seconded by Councilwoman Filippone. Vote: All of Council was in favor. The Motion Passed.

ADJOURNMENT:

A Motion was made by Councilman Horan to adjourn the Caucus/Regular meeting. The Motion was seconded by Councilman Stogdill. Vote: All of Council was in favor. The Motion Passed.
