CALL TO ORDER: Mayor Walter LaCicero, presiding

A Motion was made by Councilman Stogdill to excuse Councilman Lamb. The Motion was seconded by Councilwoman Filippone. Vote: All of Council was in favor. The Motion Passed.

**MOMENT OF SILENCE**: The Mayor stated that there has not been anyone who has passed away in town so that is a good thing. We will do a moment of silence for anyone who is in need.

**PLEDGE OF ALLEGIANCE:** Councilman Finter led us in the Salute to the Flag.

MAYOR'S WELCOMING STATEMENT: The Mayor welcomed everyone to our 2<sup>nd</sup> meeting in the new building. He stated that the Borough certainly dodged a bullet with this storm. The only big issue we had was the south end of town beaches are much eroded and the dune on Elizabeth Avenue took a beaten. We lost some sand and snow fence along the way here and there but our dune roots held strong. The Department of Public Works was here all weekend and there were some issues with their generator.

Mr. Parlow stated that there were some technical issues regarding some wiring but has since been corrected. The police department was still in the trailer and some issues with their generator so they moved up to this building during the storm. Overall, the Borough did not do too bad.

2016-76 establishing non-contractual annual salaries for Mayor and Council of the Borough of Lavallette-Councilman Stogdill requested that this resolution be pulled and put off consent. 2016-77 approving a facilities use application to the Lavallette Business Association to hold flea markets on July 16, 2016 and August 6, 2016 from 8am to 4pm 2016-78 approving a facilities use application to the MS Society to ride through our town and use our Centennial Gazebo Parking Lot as a rest stop for their bikers on May 21, 2016 between 8am to 3pm 2016-79 supporting and participating in the volunteer tuition credit program-Mayor LaCicero stated that he was told that we might already have this program on our books. This is another incentive for our volunteers to keep volunteering. 2016-80 amending and supplementing the contract with Witt/O'Brien's Associates for emergency response and disaster recovery consulting services (State Contract)-Mayor stated that this company has been helping us with our FEMA issues and the Sandy Audit. This service is 90% refundable through FEMA. 2016-81 approving the revised Administrative Order and Penalty Assessment from the Department of Environmental Protection in the amount of \$33,750 –Mayor LaCicero stated that this penalty has been floating around since 2007 and it started at \$67,500. Council President Zalom stated that Mr. Parlow had several meetings with them and managed to get it down to \$33,750. Councilman Borowski stated that it boggles his mind that we should have to pay anything at all since after Sandy we were left with no dunes, no boardwalk and barely any beach. 2016-82 authorizing the Treasurer to refund an overpayment in the amount of \$14,497.75 that was erroneously sent to the Borough of Lavallette from the State of New Jersey 2016-83 authorizing the Treasurer to issue a check in the amount of \$1,599.23 for the redemption of a tax lien certificate 2016-83A approving the amendment to the subrecipient agreement implementing grants under the Community Development Block Grant Disaster Recovery Program through the post sandy planning assistance grant program requesting a time extension-Mr. Parlow stated that this grant is to help with updating our Master Plan and the Planning Board is still doing extensive review on it so we have asked for an extension and they have agreed to extend to June.

2016-76 establishing non-contractual annual salaries for Mayor and Council of the Borough of Lavallette

Councilman Stogdill stated that there has not been any discussion on this issue and Councilman Lamb is not present and he thinks he should have some input.

Council President Zalom stated that there have been some talks on this issue. She stated that Mayor and Council do far more work than any other Council Members in other towns. Most other towns the Mayor and Council salaries are much higher than Lavallette's and we have not received an increase in over twenty years. In her opinion, she believes that all of the governing body members deserve it.

Councilwoman Filippone stated that they put in a lot of time and thinks they deserve some kind of compensation for that would be helpful. Council President Zalom did a lot of research with other towns and they are getting as much as \$10,000 for Council and \$15,000 for Mayor and in her opinion, Lavallette Mayor and Council are more hands on than any other town. She thinks it is definitely time for an increase.

A Motion was made by Council President Zalom to approve Resolution 2016-76. The Motion was seconded by Councilwoman Filippone.

The Mayor opened the floor to the public and asked if anyone wished to comment on this resolution.

Marlene Chamberlain, 904 Grand Central Avenue stated that became permanent resident just before super storm sandy and she has seen them up there all doing the best for the town and the residents without fail. She thinks that Mayor and Council definitely deserve this increase without a doubt.

There were no additional comments. The Mayor closed the floor to the public and asked Council for a vote on this resolution.

Vote: Council Members Borowski, Filippone, Zalom, and Finter voted Yes. Councilman Stogdill voted no. The Motion Passed.

Mrs. Faustini stated that by the time you draft it and then introduce and adopt it, it takes at least two months. Councilwoman Filippone stated that it could take that long also for approval of her variance and the fees are somewhat expensive.

Clem Boyers, 20 Kerr Avenue stated that before Sandy we used the council chambers and we went and got the key from the Police Department and then returned it when we were done. We do not need to be babysat. We are capable of closing everything done and being responsible.

Mark Speaker, LBA thanked Council for the approval of the flea markets. This is just one more thing that gets us back to normal. As for Mr. Parlow retiring, the LBA is very grateful for all your help through the years and you definitely will be missed.

Marlene Chamberlain, 904 Grand Central Avenue stated that she has great respect for Mr. Parlow and applaud him for all his work during the storm and getting Lavallette back to where it was pre sandy so quickly.

Jean Verrier, 14 Virginia Avenue thanked Council for approving the triathlon. We have a lot of ideas and hope it's a great event for all.

Jon Corney, 1 Newark Avenue stated that Mr. Parlow did a hell of a job on the appropriations report and even better on the revenue report.

Mr. Parlow thanked him.

Mr. Corney questioned if we were going to have any public budget hearings at all this year.

Mayor LaCicero stated that there will only be one hearing as always and it will not be public.

Mr. Corney questioned when the budget was going to be ready to go.

Mr. Parlow stated that he is hopeful to have the budget introduced at the second meeting in February.

#### COMMENTS OF THE MAYOR AND COUNCIL MEMBERS:

Council President Zalom stated that she was very excited about Founder's Day and the flea markets coming back. We still have \$20,800 left in our CDBG Funds and we were looking into putting a handicap accessible ramp on Trenton Avenue but it's not enough funds. We do know that FEMA will reimburse us 90% of the costs if we put the handicap ramps we had before back on Jersey City Avenue and Brown Avenue. We will have to discuss this further and figure out what we want to

Councilwoman Filippone questioned how long we had to spend the money.

Council President Zalom stated that we had one year.

Councilwoman Filippone stated that in the meantime we can look at mobi-mats that are different then the ones we have with a different company. That might be a better alternative for right now.

Councilman Finter stated that there was some information from NJNG that he left on the back table for anyone who was interested.

Councilman Borowski stated that our Public Works Department did a phenomenal job with clearing the streets of snow and still had time to pick up all the garbage on Monday.

Mayor LaCicero stated that the south end of town had a loss of power around 3:30 am on Saturday morning and even in that constant downfall of snow our guys were up on that pole fixing the electric. Soon after that the whole town went out due to JCP & L.
