appointing Douglas Erb as the temporary Construction Official until November 30, 2016 at an hourly rate of \$40.00-Mayor LaCicero stated our new permanent Construction Official will be starting at the end of the month so we need to keep Mr. Erb until then as well.

authorizing the Construction Official to appoint a designee as Flood Plain Manager for the Borough of Lavallette-Mr. Bennett stated that our old Construction Official Ken Kiseli has left and he was the Flood Plain Manager. We need to have our new Construction Official be able to designate someone as designee to be the Flood Plain Manager so he can appoint Gary Royer to do it right now. Once we have a permanent Construction Official he will get the certification as well.

#### ORDINANCE ON FOR PUBLIC HEARING AND FINAL ADOPTION:

BOND ORDINANCE NO. 2016-14 (1158) BOND ORDINANCE PROVIDING FOR ROAD IMPROVEMENTS TO ELIZABETH AVENUE AND DOVER AVENUE, AND APPROPRIATING \$270,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$120,000 BONDS AND NOTES TO FINANCE A PORTION OF THE COSTS THEREOF, AUTHORIZED IN AND BY THE BOROUGH OF LAVALLETTE, IN THE COUNTY OF OCEAN, NEW JERSEY
