## **UNFINISHED BUSINESS:**

Mr. Bennett stated that he just wanted to give some praise to the Lavallette Police Department for apprehending the person who robbed the Sunoco station back in June of 2017. They did a great job of investigating and with the help of other towns that seemed to have the same issue with the assailant they were able to make an arrest. Also, the Teamsters 469 Public Works Contract will start their negotiations soon. They seem to have an issue with our request for mandatory CDL licenses so he will reach out to Mr. Potter from the Teamsters and discuss this with him. Also, there were some issues regarding the food truck festival of October 15<sup>th</sup> that was sponsored by the LBA. Apparently, at the last minute, some electrical needed to be installed for the beer tent. The beer was being sold by the Lavallette Fire Department and they received the profits from the sale however the LBA seemed to be overcharged for that particular cost that they should not have had to pay. In the future, these issues should be worked out ahead of time to prevent the overcharges. This seems to have been the first time that this issue has occurred so maybe it was just a one time thing. As long as Public Works is notified ahead of time, there won't be a problem regarding the overtime because the work can be done while they are still working before the weekend.

#### **NEW BUSINESS:**

FSD Enterprises, Declan O'Scanlon-Agreement to Continue Professional Services.

Mr. Bennett stated that Mr. O'Scanlon has sent over this agreement to continue his services for the cell towers consultant. This contract has expired as of 2015 so if we want to continue his consulting services we should go ahead with this agreement.

Mayor LaCicero stated that he thinks it is a good idea to continue his services. If we don't use him, we won't be charged but at least we will have the agreement in place. We will put it on for the next meeting.

Discussion on a Petition for a "Weekend Construction Moratorium submitted by Mary Logios and Sandee Malenky, both of Sterling Avenue.

Mayor LaCicero stated that we received a petition from two residents from Sterling Avenue for a moratorium on weekend construction during the summer months.

Council President Zalom stated that she doesn't think we are ready for this yet. We still have homes that are being constructed due to Sandy. The weather over here doesn't even start getting good until the summer months. Our spring season is still too windy and cool, and also too rainy. Also, our summer residents like to be here when there houses are under construction so they schedule during the summer months.

Councilman Borowski stated that he reached out to some local contractors in town and they advised me that they would have no issue with just not allowing it on Sundays but they utilize their Saturdays for finishing up jobs and prefer to leave that day open.

Councilman Lamb stated that he agrees that our weather really doesn't start getting really nice every day until June through summer.

Council President Zalom stated that maybe we can look at it again next year after we see how much construction is going on next summer.

Councilman Finter stated that his only issue is it not being fair to renters who come to Lavallette to enjoy their vacation only to be bothered by all the construction going on around them with the noise.

Councilman Stogdill stated that he would have no issue with not permitting it on Sundays but Saturdays is another work day for them.

Mayor LaCicero asked both women who submitted the petition to come to the microphone and speak about their issue.

Mary Logios, 4 Sterling Avenue, thanked the Mayor for accepting the petition and allowing them to speak about it. There has to come a time when the full time residents get to enjoy their quality of life with some peace and quiet for a little while. Even when we go to the beach we can still hear the noise of saws, machines and hammers. Bay Head and Mantoloking have already done this so what makes us any different?

Sandy Malenky, 6 Sterling Avenue, stated that Sandy was five years ago. Probably 85% of the homes are all redone and complete. We just want to be able to enjoy our peace and summer months like we did before the storm when there was not as much construction as there has been since the storm.

Mrs. Logios stated that they are only asking for the weekends during the summer months, which is not a lot to ask. Once contractors know they have a time limit to get their work done, they seem to move faster anyway so they can get paid.

Mayor LaCicero stated that they made a good case but none of Council has seemed to put a motion on the floor so it doesn't look like you are going to get this done for next year.

## **COMMENTS FROM THE PUBLIC:**

Chris Chamberlain, 26B Bond Avenue, stated that the FAA is pushing to commercialize these unmanned aircrafts known as drones. He would like Council to put something in writing to object to this.

Mr. Bennett stated that Mr. Chamberlain should get all the information needed and give it to Donnelly and we will take care of writing something up.

Mr. Chamberlain also stated that 902 Ocean Front has been boarded up for over a year now and they just noticed the other day that the board where the door is has been pulled off so the house is now exposed.

Mr. Bennett stated that we will make sure that gets taken care of.

Bob Astorino, 2 Elizabeth Avenue, questioned what the delay was regarding the Elizabeth Avenue paving?

Mr. Bennett stated that he questioned that himself. He spoke to the Engineer and he has been told that the work will start again this week.

Jon Corney, 1 Newark Avenue, stated that the bocce ball courts are in serious need of repair.

Councilman Lamb stated that Public Works has already raked it but they are not experts on bocce.

Mayor LaCicero stated that he discussed this issue with another resident in my office and he was supposed to bring me a proposal on repairing the courts. Hopefully, he will get that to us so we can look into it.

Mr. Corney stated that the boat ramp needs cleaning out so badly. It really needs to be revamped or something.

Mayor LaCicero stated that we are already looking into some new grants coming out for that reason. There are grants called iboat that will give you the money through the grant to revamp this boat ramp.

Mr. Corney stated that he will miss Mr. Bennett. He wishes him well.

Mayor LaCicero stated that he just realized he needed to get approval for the Personnel Committee to go over the applications and schedule interviews. The Committee will consist of Councilman Borowski, Councilwoman Filippone and himself.

A Motion to approve the Personnel Committee was made by Councilman Lamb. The Motion was Seconded by Councilman Stogdill. Vote: All of Council was in favor. The Motion Passed.

#### COMMENTS OF THE MAYOR AND COUNCIL MEMBERS:

Councilman Borowski stated that he just wanted to say that Mr. Bennett has always been a gentleman and professional and he will be missed. He wishes him all the best in the future. He has been a delight to work with and always very responsive. His attention to detail was always remarkable.

Council President Zalom seconded those comments. He will be sorely missed and she wished he could have stayed. She stated that there is a non profit organization that would like to come and discuss building a playground area at no cost to the Borough. If a playground is not sufficient they could do something else for the bay front. I would like to schedule him to come for the meeting of December 18<sup>th</sup> for the discussion.

Councilman Lamb stated that he too is going to miss Mr. Bennett. We had a great 19 months with him. He wishes him well.

Councilman Finter stated that Mr. Bennett will be missed. It was a pleasure working with him. He was always accessible no matter where he was.

Councilman Stogdill stated that he was going to miss his conversations with Mr. Bennett and wishes him all the best.

Mayor LaCicero stated that he is not happy that he is leaving. He will definitely be missed. He wishes him well.

#### **EXECUTIVE SESSION:**

Mr. George stated that there is a need to go into executive session to discuss two contractual matters regarding the PBA and the Teamsters 97 contracts. There may be action taken when we reconvene.

A Motion to adjourn the Caucus/Regular meeting to go into executive session was made by Councilman Finter. The Motion was Seconded by Councilman Borowski. Vote: All of Council was in favor. The Motion Passed.

The Caucus/Regular Meeting was adjourned to go into executive session at 8:09 pm.

A Motion to reconvene the Caucus/Regular Meeting was made by Council President Zalom. The Motion was Seconded by Councilman Finter. Vote: All of Council was in favor. The Motion Passed.

Mr. George stated that while in Executive Session we only discussed the Teamsters 97 contract first. There was discussion on the duration of the contract and also salaries and a step guide. There is action that needs to be taken to approve the Memorandum of Agreement.

A Motion to approve the Memorandum of Agreement with Resolution 2017-308 was made by Council President Zalom. The Motion was Seconded by Councilman Finter. Vote: Council Members Borowski, Zalom, Finter and Lamb voted Yes. Councilman Stogdill was not present for the executive session. The Motion Passed.

Councilman Borowski stated that it should be on the record that there are five Administrative employees that are in this contract.

Mr. George stated that the executive session needed to be broken into two sessions due to one Council Member not being able to attend the Teamsters 97 discussion and the Mayor and a Council Member not being able to attend the discussion on the PBA contract.

Mr. George stated that we will now go into an executive session to discuss the PBA Memorandum of Agreement. There may be action taken when we reconvene.

A Motion to go into another executive session was made by Council President Zalom. The Motion was seconded by Councilman Borowski. Vote: All of Council was in favor. The Motion Passed.

The Caucus/Regular Meeting was adjourned at 8:46 pm.

A Motion to reconvene the Caucus/Regular Meeting was made by Councilman Finter. The Motion was Seconded by Council President Zalom. Vote: All of Council was in favor. The Motion Passed.

The Caucus/Regular Meeting was reconvened at 9:42pm.

Mr. George stated that while in executive session there was discussion on the PBA Memorandum of Agreement. No action will be taken tonight.
