O'Donnell, Stanton & Associates Proposal of Services for Philadelphia Avenue Road Improvements/Received May 17, 2019

Councilman Lamb stated that this is to start the process for our Philadelphia Avenue road improvements and is always basically a boiler plate proposal for these road projects.

A Motion to approve this proposal was made by Councilman Borowski. The Motion was Seconded by Councilwoman Filippone. Vote: Council Members Borowski, Filippone, Zalom, Stogdill, Finter and Lamb voted Yes. The Motion Passed.

Renumbering Request from 145 Jersey City Avenue to 1918 Bay Blvd. from Gayle Quattrone

Councilman Lamb stated that this property is on the corner of Jersey City Avenue and Bay Blvd. and if the mailing address with the post office is the Bay Blvd. address it should be uniform.

The Municipal Clerk stated that she will put this on a resolution for approval at the next meeting.

#### **COMMENTS FROM THE PUBLIC:**

Mary Logios, 4 Sterling Avenue requested an update on when the yellow lines will be painted on Bryn Mawr and Sterling to prevent the cars from parking in that area because of the difficulty of being able to see coming out of Sterling.

Councilwoman Filippone stated that the Chief is aware of it and has gone out to assess it and it will get done at some point.

Mrs. Logios stated that she would like it to be done before Memorial Day to prevent any issues with the parking.

Councilman Lamb stated that he will talk to the Chief about it and see if it could get done before then.

Bob Astorino, 2 Elizabeth Avenue questioned if the benches would be on the walkovers before the season starts? If not, can people use their own chairs?

Council President Zalom stated that we are still unsure if they will be up there for the season but anyone can use their chairs to sit up there.

Jon Corney, 1 Newark Avenue questioned when all the signs would be up for the season? He also questioned if the motorized scooters are allowed on the roads in town?

Councilwoman Filippone stated that she believes that the scooters are allowed on the roads but we do have an ordinance that bans golf carts.

Councilman Lamb stated that the signs will all be up by the season.

#### COMMENTS OF THE MAYOR AND COUNCIL MEMBERS:

Councilman Finter stated that now that the replenishment project is complete we will be putting up the interpretive signs like the ones down at the bay front. He stated that he also wants to thank Mark Speaker and his wife for maintaining all the bulletin boards in town.

Council President Zalom stated that everything is set for our Memorial Day Services. The town wide garage sale is set for the first weekend in June.

Councilman Borowski stated that the trees that Beautification donated by the ballfield look fantastic.

Councilman Lamb stated that the fire department is interested in doing a program for Junior fire fighters. Bob is looking into the effects of this with our insurance and if there would be any discrepancies regarding the age.

Councilwoman Filippone stated that last week was National Police Week so we just want to give some credit toward our Police Department.
