#### **PUBLIC HEARING OF THE 2022 BUDGET:**

A Motion to open the public hearing was made by Councilman Borowski. The Motion was Seconded by Councilman Finter.

Vote: All of Council was in favor. The Motion Passed.

Mr. Oliwa state that the 2022 budget was introduced and approved on April 4, 2022. This year is another flat rate and also a fantastic collection rate of taxes and grade AA for finances for the last three years given by Standard & Poors. Lavallette is the seconde lowest tax rate in the County and the 3<sup>rd</sup> lowest in the State. The utilities are self-liquidating There were some normal increases in the budget for pensions, health benefits and a slight increase for cyber security updates. The debt service is doing great.

Councilman Borowski stated that it is remarkable that our debt is dwindling down so quickly. It is very impressive.

The Mayor asked if anyone in the audience wished to comment on the 2022 budget.

No one wished to comment.

A Motion to close the public hearing was made by Councilman Finter. The Motion was Seconded by Councilman Lamb.

Vote: All of Council was in favor. The Motion Passed.

#### **ADOPTION OF THE 2022 BUDGET (Resolution 2022-134)**

A Motion to adopt the 2022 budget was made by Councilwoman Filippone. The Motion was Seconded by Councilman Finter.

Councilman Lamb questioned why we all of a sudden this has become an issue. This has always been a tourist town with summer rentals and never have we had so many issues with renters and garbage.

Councilman Borowski questioned why the renters just don't take the trash down to the recycling center on their own right before they leave like renters before them have done for all these years. It should be stipulated in the rental lease that is a requirement and rule.
