**MAYOR'S WELCOMING STATEMENT:** The Mayor welcomed everyone to tonight's meeting. He stated that the Army Corps. sent us the agreement regarding the beach replenishment and it is going to cost the Borough \$670,000. The County has agreed to pick up 50% of the costs which helps us out a lot but even half of that is still a lot of money for us to put out but we have no choice because we do not have the option to decline. Also, we had another Engineer go over all the well project to give a second opinion on if this project is necessary since it is going to cost us 3.7 million and he should be getting us his analysis report very soon.
