ORDINANCES ON FOR PUBLIC HEARING AND FINAL ADOPTION:

Ordinance No. 2025-06 (1270) An Ordinance of the Borough of Lavallette Amending, Revising and Supplementing Certain Sections of Chapter 90 Section Section 9 Regarding Nonconforming Structures and Uses

A Motion to open the public hearing was made by Councilman Borowski. The Motion was Seconded by Councilwoman Filippone.

Vote: All of Council was in favor. The Motion Passed.

Councilwoman Filippone stated that this ordinance will allow all pre-existing nonconforming secondary seasonal structures to install central air conditioning only. This ordinance does not allow the installation of heating but pre-existing nonconforming secondary seasonal structures who, as of this date, already have approved heating can still repair or replace those heating elements as necessary.

The Mayor opened the public hearing and asked if anyone wished to comment on this ordinance.

No one wished to comment.

The Mayor closed the public hearing and asked Council for a vote on this ordinance.

Vote: Council Members Borowski, Filippone, Zalom Stogdill, Finter and Shenewolf voted Yes. The Motion Passed.

UNFINISHED BUSINESS:

There was no unfinished business.

NEW BUSINESS:

Councilman Borowski stated that since the commercial businesses have been having their garbage picked up by an outside vendor our tonnage percentages and fees have decreased by 20%. Our bulk waste has gone down as well.

Mayor LaCicero stated that the businesses have had such positive effect with this new system that they have opted to stay with the outside vendor all year round.

Councilman Borowski stated that our reverse 911 system will be going out to our residents once again advising them of the 5 highest heat days so they can try and conserve electric during these days.

Mayor LaCicero stated that he is thankful we are part of the Public Power Association and have our own electric because that has allowed the Borough to be able to not have an increase in electric rates for this year.

Mr. Bennett stated that the curbing project for Westmont Shores is 80% complete so far and also we have started a new bench program so if you are interested and couldn't make the 1st bench list you can try again.

Mr. Burns stated that the Memorial Day Speaker wanted him to thank Mayor and Council for allowing her to be part of the services and stated that she was very impressed how we handle our Memorial Day Services.

COMMENTS OF THE MAYOR AND COUNCIL MEMBERS:

Councilwoman Filippone stated that the 200 Club honored our three officers for their bravery in saving the life of a man who was having a heart attack.

John Bennett asked every to pray for Ted Golubowski and his family as his 27 year old son is fighting for his life right now.

Mayor LaCicero stated that Rite-Aid closing is going to cause some big changes in town. Concerned about what will happen with the building vacancy. We might need to look into readjusting our ordinances if necessary.

COMMENTS FROM THE PUBLIC:

Brian Hughes, 11 Princeton Avenue stated that he came to one of the February 2025 Council meetings about the trash not being picked up from the garbage receptacles on the boardwalk and since then it has gotten slightly better but still needs some improvement.

Councilman Finter stated that he will discuss this with our Public Works Supt.

EXECUTIVE SESSION:

There was no executive session.

ADJOURNMENT:

A Motion to adjourn the Council Meeting was made by Councilman Finter. The Motion was Seconded by Councilman Borowski.
