**AN ORDINANCE OF THE BOROUGH OF LAVALLETTE
ESTABLISHING SALARIES AND WAGES OF OFFICERS AND

BE IT ORDAINED by the Borough Council of the Borough of Lavallette in the County of Ocean, State of New Jersey as follows:

SECTION 6. This ordinance shall take effect immediately upon its enactment after second reading and publication as required by law.


